DCU is Ireland's University of Enterprise – globally engaged research intensive university with a strong focus on enterprise and technology. We are in the top 4% of universities worldwide and one of the leading young universities.

We have come from establishment just over 20 years ago to the top 4% of universities worldwide and one of the leading young universities – dynamic and vibrant

Student population of almost 16,000, 2,000 non-Irish students from 115 different countries.

More than half of Dublin's population is under 25 making us one of the youngest capitals in the world.

- 2008 Established an AFU Working Group
  Worked with External Advisors to develop 10 Principles of an
  Age Friendly University
- 2012 Launched Age Friendly University Network in partnership with Arizona State University and University of Strathclyde, Scotland
- 2014 Reformed the AFU Working Group to an AFU Implentation Action Team – multi-disciplinery Appointed AFU Network Coordinator

### AGE FRIENDLY PRINCIPLES

### **Age Friendly Principles**

DCU has identified 10 Principles for an Age Friendly University:

- To encourage the participation of older adults in all the **core activities** of the university, including educational and research programmes.
- To promote personal and career development in the second half of life and to support those who wish to pursue "second careers".
- To recognise the range of educational needs of older adults (from those who were early school-leavers through to those who wish to pursue Master's or PhD qualifications).
- To promote intergenerational learning to facilitate the reciprocal sharing of expertise between learners of all ages.
- To widen access to **online educational opportunities** for older adults to ensure a diversity of routes to participation.



### **AGE FRIENDLY PRINCIPLES**



#### cont...

- To ensure that the university's **research agenda** is informed by the needs of an ageing society and to promote public discourse on how higher education can better respond to the varied interests and needs of older adults.
- To increase the understanding of students of the longevity dividend and the increasing complexity and richness that ageing brings to our society.
- To enhance access for older adults to the university's range of health and wellness programmes and its arts and cultural activities.
- To engage actively with the university's own retired community.
- To ensure regular dialogue with organisations representing the interests of the ageing population.


- DCU Walkability Survey

- MedEX Programme medical exercise programme 700+
- Active for Life Programme 200
- Intergenerational Learning Programme customised non-credit bearing courses 400 +
- **Dementia Elevator Programme** caring for people with Dementia, supporting carers and providing free training for retail, financial services and leisure industry staff 200+ participants
- Cultural and educational opportunities for older people to engage with DCU ongoing programme
- Access to existing academic credit bearing modules from our existing undergraduate programmes – breaking down barriers for older people to engage with DCU by providing flexiblity towards achieving an award

- Over 40 research multidisciplineary projects in progress yielding in excess of €4m to DCU



### Age Friendly University Snapshot 2016

- DCU is recognized by government departments, statutory organisations, academic and research organisations and NGO's as leading the Age Friendly University Initiative.
- DCU hosted the first international Age Friendly Universities 2 day conference "Engaging Ageing" 160 delegates/24 higher education institutions. Another conference planned for Nov 2017
- Enhanced opportunities for older people to engage across campus through participation education/cultural and research which brought an additional 2,000 older people onto campus in 2015 –
- Endorsed by the Association for Gerontology in Higher Education global leaders in education on ageing
